What data do we collect?

How will we use your data?

How do we store your data?

Bakator Kft. securely stores your data and constantly monitors personal data protection.

Marketing

What are your data protection rights?

Bakator Kft. would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Bakator Kft. for copies of your personal data.

The right to rectification – You have the right to request that Our Company correct any information you believe is inaccurate. You also have the right to request Our Company to complete information you believe is incomplete.

The right to erasure – You have the right to request that Our Company erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Our Company restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Our Company's processing of your personal data, under certain conditions.

The right to data portability – You have the right to object that Our Company transfer the data that we have collected to another organization, or directly to you, under certain conditions.

What are cookies?

Cookies are text files placed on your computer to collect standard Internet log information and visitor behaviour information. When you visit a website, we may collect information from you automatically through cookies or similar technology.

This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.
